United Way of Southwest Alabama Community Care Card Program Agreement

THIS AGREEMENT, on _____, 2019 is made by and between the United Way of Southwest Alabama, hereinafter called "United Way," an Alabama nonprofit 501(c) (3) charitable organization and

_____, hereinafter called "Merchant."

Agreement Summary

The parties agree:

1. United Way will operate the Community Care Card Program, hereinafter called the "Program;"
2. In connection with the program, United Way will issue the Community Care Card, hereinafter called the "Card," to be honored by participating Merchants,
3. United Way will issue the Card to qualifying donors, hereinafter called "Cardholders," who meet specified yearly monetary contribution criteria. United Way will also assume all responsibility for the distribution of the Card to the Cardholders,
4. Merchants who participate in the Program will honor the Card in connection with the sale of merchandise and/or services that will result upon presentation by the Cardholder of United Way's Card at Merchant's establishment(s).

I. Acceptance of Card by Merchant

Subject to the provisions contained in the Agreement, the Merchant shall accept the Card when presented for payment for reduction in the total purchase price for either services or items purchased from Merchant in accordance with its Agreement with United Way (defined below).

In accordance with the above, the Agreement that Merchant has with United Way is as follows:

1. Merchant agrees not to discriminate against any person using, or deriving use, of the Card.
2. Merchant and United Way agree that Merchant is not obligated to honor the Card in conjunction with any other discounts/offers made by Merchant,
3. The Card may be used by the Cardholder at the Merchant's place of business, once per visit, with unlimited visits for a period including January 1, through December 31, 2020, after which Merchant shall be free of its obligations hereunder, unless under an additional Agreement.

II. Duration and Termination

This agreement between United Way and Merchant shall continue in full force and effect from the effective date of January 1, through December 31, 2020, after which Merchant shall be free of its obligations hereunder, unless Merchant renews under an additional Agreement.

III. Notification

United Way agrees that it shall display on its website a notification that the Merchant, who is party to the Agreement, is a participant in the Community Care Card Program.
